Rules of Discussion

Rule 1: The Greeting, "Madam Basileus and to all who serve Alpha Kappa Alpha, Good Afternoon", should only be stated by the first speaker of the meeting.

Rule 2: At the beginning of committee reports and debates and before the meditation, all others need only to acknowledge the Basileus by saying, "Madam Basileus, Good Afternoon".

Rule 3: To seek recognition from the chair, a Soror shall raise her hand using the raise hand feature located in the participant section or reactions box, or type her question in the chat box.

Rule 4: Sorors must be recognized by the Basileus before speaking and should direct all comments and questions to her.

Rule 5: Keep your comments brief and on task.

Debates:

Total debate time shall not exceed 10-minutes.

- Each soror will have two- minutes per debate.
- No soror may speak more than once per issue.
- During debate, all comments and questions should be directed to the Basileus.
- After a motion is made and the Basileus asks, "Are you ready for the question?" there should be no response from the chapter. Unless there is un-readiness. If there are no additional questions, the chapter will vote on the motion.
- The Basileus, pending approval of the voting body, may make exceptions to the debate rules

Good Afternoon Sorors,

It's a great day to be an AKA. In today's Basileus report, I'll share key information from the 68th Mid-Atlantic regional conference, provide dates for several important upcoming events, offer a recap of our Executive Committee 90-Day Check-in, and give tea roses to our sorors who are doing excellent work in Chi Rho Omega.

Mid-Atlantic Regional Conference

Congratulations to Madam Regional Director Jennifer King Congleton and the 68th Mid-Atlantic Regional Conference Committee for planning and executing an excellence conference. The virtual experience was just as rewarding as the in-person experience. I enjoyed watching Twenty Pearls, and learning more about the virtual Ivy Beyond Wall Ritual and technology in the Saturday workshops. I watched our Silver Stars get recognized, cheered when our legacy Sorors appeared on the screen during the Legacy Parade and enjoyed a spirit filled short Sunday worship service.

There were 630 registered delegates and nearly 5,000 registered attendees. 77 CRO Sorors registered.

State of the Sorority

The state of our sorority is strong.

- Chapters have continued to provide meaningful service to our communities amid a global pandemic under our seven impact days and five program targets.
- Overall, Sorors have provided 3, 195,854 hours of service for the 2020 program year.
- For the third year in a row, we raised \$1m in one day for HBCU Impact Day
- We exceeded our 50,000 enrollment goal for #CAP and enrolled 139,516 students since 2019
- 1.5 million women have been reached through our Target 2 programs, exceeding our goal to educate women on breast cancer awareness, heart health nutrition for life and care for the caregiver.
- We've educated 4.3 million people on money matters with 2,5000 chapter financial planning programs.
- Supported 4,038 AKA owned businesses and entrepreneurs.
 - Our buy black campaigns have generated \$29M for black businesses
- Through Target 4 we exposed 146,000 students to the Harlem Renaissance
- In Target 5: Global Impact we've collected 148,000 pairs of eyeglasses, made 14,807 pillowcase shirts and 100,958 pillowcase dresses.
 - We donated 554,958 pairs of shoes making AKA the largest shoe donor partner with Sole 4 Soles

Membership

- Our membership total has reached the highest number in our 113 year history
- We ended 2019, more than 87,000 active sorors including 8,334 sorors who reactivated in 2019
- 2,398 Sorors welcomed back in 2020

- 1255 new sorors welcomed into AKA through Modified MIP

State of the Region

In the Mid-Atlantic Region, we have continued to do a new thing.

- 5,724 students completed enrollment process into #CAP
- We provided \$187K in scholarships for HBCU students
- We also donated more than \$281 donated directly to HBCUs
- We delivered 543 health and wellness programs
- In target three, the region provided 168 programs on credit repair, entrepreneurship and more
- We generated \$1.2 Million for small black owned businesses through buy black campaigns
- Through Target 4, more than 300 programs, exposed over 12,000 students to the arts
- We were busy in Target five. The region collected 12,990 pairs of shoes, 4,600 pairs of glasses and made 5,545 pillowcase dresses and 394 pillowcase shirts
- More than 4700 refugees were assisted in North Carolina and Virginia

Our presence remained strong during AKA Impact Day as we provided a number of programs.

- 248 MLK Day
- 199 Pink Goes Red (before COVID-19)
- 229 Breast Cancer Awareness Day
- 250 Caregiver's Day
- 138 Global Impact Day
- 239 International Day of Prayer

The Mid-Atlantic region raised \$200,139 of \$1.3 million raised on HBCU impact day

Membership

The Modified MIP Process provided 137 new undergraduate sorors in 2020.

- Spring 2020 - 2 chapters initiated 27 new members
- Fall 2020 - 9 chapters initiated 110 new members
- Over the last three years. MAR Membership has grown from 7,500 to 11,400 due to MIP and reactivation

Amendments presented

During the Second Plenary Session eight proposed bylaw amendments that will be voted on at Boule were presented. I listed them in my report for your review.

1. Amend Article 1, Section 15(i) to change the name of the Connections Committee to the Connections and Social Action Committee to better describe the work of the committee.
2. Amend Article 1, Section 15(j) to revise the number of members on the Building and Properties Committee from five members to a minimum of five members.

- a. The revised wording will allow more flexibility in the number of sorors overseeing the sorority's property as the organization continues to grow.
3. Amend Article 1, Section 15(m) change the Technology Committee composition from seven members to, one of whom must be a member of the Finance Committee to having a Chairman and representative from EACH region, one of whom must be a member of the Finance Committee.
 - a. The growing reliance on technology in the sorority's work has demonstrated the importance of having a representative from each region on the International Technology Committee
4. Add to Article 1, Risk Management, as a standing committee.
 - a. This amendment would institutionalize Alpha Kappa Alpha's commitment to actively safeguard the sorority's mission, brand, reputation, and resources, while underscoring the importance of effective risk management to achieve this end.
5. Amend Article II (2), Section 20 to clarify that chapters are not freestanding and that all contracts beyond \$100,000 require approval by the Supreme Basileus.
6. Amend Article IV (4), Section 9 to add a subsection that an active soror who has been a member of the sorority for seventy-five (75) years may obtain membership by application of to the Corporate Office without payment of additional fees.
7. Amend Article (IV) 4, Section 32 to change the name co-sponsor to recommending soror and indicate that one of the recommending sorors may be a soror who is not in the chapter where the candidate will be initiated.
 - a. This amendment would broaden the base of sorors who are eligible to recommend a candidate for membership/
8. Amend Article XV (15) to clarify that bylaw amendments, adopted at the Boule that impact chapters, shall be added to the chapter's bylaws without having to follow the amendment process noted in the chapter's bylaws.

I would like to focus on three due to time:

- Add to Article 1, Risk Management, as a standing committee.
 - This amendment would institutionalize Alpha Kappa Alpha's commitment to actively safeguard the sorority's mission, brand, reputation, and resources, while underscoring the importance of effective risk management to achieve this end.
- Amend Article (IV) 4, Section 32 to change the name co-sponsor to recommending soror and indicate that one of the recommending sorors may be a soror who is not in the chapter where the candidate will be initiated.
 - This amendment would broaden the base of sorors who are eligible to recommend a candidate for membership/

Amend Article XV (15) to clarify that bylaw amendments, adopted at the Boule that impact chapters, shall be added to the chapter's bylaws without having to follow the amendment process noted in the chapter's bylaws.

Please review them. We will discuss and vote on them during our May Meeting.

Greetings. The Program Committee report for April 2021 is as follows:

Target I: HBCU for Life & #CAP Collaboration

HBCU for Life and #CAP hosted a collaborative workshop entitled: CFNC, HBCUs & PWIs: Oh My! on Saturday, April 10th from 1:00pm – 2:30pm. The workshop consisted of a guest speaker Sarita Broadway, Senior Regional Representative from the College Foundation of North Carolina; who provided a plethora of information on how students can view Information on colleges through their website and locate pertinent Information on application requirements, college tours and tuition information.

After the guest speaker, there was a panel discussion with current and past Alumni of HBCU/PWI, where they discussed their experiences attending their prospective institutions and answered audience submitted questions such as, their majors and why they chose to attend an HBCU/ PWI. Article IV – Meetings (Section 1b)

Current:
